Success...

Both ammendments, the Neighborhood Conservation Overlay and Spring Garden Street Pedestrian Scale Overlay were approved and adopted by the Greensboro City Council in the past 30 days.

Lindley Park and the City developed a strategic Neighborhood Plan that was approved in 2003. The two amendments recently passed will enhance our plan. The Neighborhood Conservation Overlay (NCO) is a City wide ordinance with a simple purpose of "establishing regulations to enhance natural, economic, and architectural resources unique to specific areas of the city while protecting neighborhoods from incompatible development." For example: When the Hamilton Lakes land use restrictions on the Walker Avenue property between Holden and W. Market St. expires in July 2007 and the management company that bought or is buying all of the houses on Walker, if they choose to commercially develop this land then Lindley Park will be involved with zoning and planning using the NCO.

The Spring Garden Street Pedestrian Scale Overlay creates an overlay district and design manual that promotes quality and compatible redevelopment through flexible and clear design standards. An important goal of the design manual is to help property owners, developers, architects, engineers, and planners meet the vision of the Spring Garden Street corridor as stated in the Lindley Park Neighborhood Plan. The concepts included in the manual are based on fundamental principles of good site, architectural, and urban design. The manual is also intended to go beyond the role of a regulatory document and be used as an educational tool.

The Shoppes at Lindley, the proposed development next to Peppers Den and the proposed "Condos for Sale" between Elam and Scott all reflect the design and quality that will enhance Spring Garden Street. The developers of these properties have sought input and support from Lindley Park.

Message From The Chair

Dear Lindley Park Neighbors,

UNCG updated its Master Plan for growth this year, a process they go through every few years to make sure they can satisfy anticipated needs of the university. Planners held two public meetings and made their findings and proposals for long-range growth available online in the form of a slideshow viewable at:

http://projects.sasaki.com/uncgreensboro/Documents/UNCG_WORKSES-SION3_4_18_07.pdf. Of great relevance to our neighborhood is the proposed athletic center with practice soccer fields, tennis courts, and indoor pool, along with UNCG-owned student housing and parking lots on the land bordered by Spring Garden Street and Oakland Avenue between the existing UNCG warehouses on Northridge Street and McManus Street. The area is mapped, and its uses described, on page 80 of the 82 pages on the website above.

This area of our neighborhood is included in the new Spring Garden Street Pedestrian Scale Overlay District, a designation that directs all new development to support neighborhood walkability and compatibility through design guidelines. The Spring Garden Street Pedestrian Scale Overlay District, which was adopted by the City Council on May 1st, 2007, is a significant result of the three-year collaboration between City staff and Lindley Park industrial property owners, developers, and resi-

dents, whereby a vision for the neighborhood's future was defined.

The Lindley Park Neighborhood Association's upcoming general meeting, on May 29th, will focus on the future of this area of the neighborhood. Representatives from UNCG will present the updated Plan and ask for feedback from the community. Representatives from the Greensboro Planning Department will also be present to provide insight into the plan's possible impact on the neighborhood and the Spring Garden corridor. I hope that you will come to this meeting, ask questions, and share your thoughts.

The meeting begins at 7:00 pm on Tuesday, May 29th, at the Lindley Recreation Center at 2970 Springwood Drive.





LPNA Bylaw Revision

Recently the LPNA Executive Board has encountered situations that need action prior to the regularly scheduled Executive Board meeting and there was not enough notice to establish a meeting time that a significant number of Board members could attend. This has usually been related to a zoning request or other time critical matter on the city calendar. In order to effectively deal with such situations a revision to the bylaws is proposed as follows:

In Article VII Executive Board, Section 4. Special Meetings, retain the existing wording and designate as item "A" as follows;


A. Special meetings of the board may be called by the chairman, and shall be called by him at the written request of seven members of the board. No business other than that for which a special meeting is called shall be transacted except by unanimous consent.


and then create an additional section "B" as follows

B. On occasion a decision on a specific topic may be required from the Executive Board prior to its next scheduled meeting. In lieu of calling a special meeting the chair may notify the board members by email of the need for a timely decision. The subject line should read: "LPNA Exec Board vote needed". The body of the email should include background information, an explanation of the issue and a request for a response for or against the proposal by return email. Any action must have 10 votes in support (a simple majority of the 18 positions on the Executive Board) and the Chair must post the vote tally by email prior to carrying out the decision. The chair must also provide a report of the results at the next board meeting so they may be officially recorded in the minutes.

A discussion and vote on this change will be part of the business at the May 29th General Meeting.







Proposed Changes To The Greensboro Noise Ordinance

The Greensboro Neighborhood Congress has been working with the City to strengthen the noise ordinance so that it is finally enforceable. The draft of the ordinance was completed May 14, 2007 and will go before the City Council for adoption in the near future. The LPNA Executive committee will be notified and will represent the neighborhood.

This is important for Lindley Park residents because we share the neighborhood with commercial properties. Although the 'Corner' (Elam and Walker) are generally good neighbors there was a situation with partying on the deck at the Blue Marlin last Summer. The existing noise ordinance is barely enforceable and has no teeth. Below a portion of the draft. If you want a full copy email bill@billeckard.com and a copy will be forwarded to you.

DRAFT - Greensboro Noise Ordinance May 14, 2007

ARTICLE IV. OFFENSES OF UNREASONABLE OR DISTURBING SOUND

Sec. 18-47. Preamble.

The provisions hereinafter contained are enacted for the purpose of preventing noise disturbances or unreasonably loud noise, and are enacted pursuant to the authority granted in N.C.G.S. § 160A-184. Above certain levels or durations and during specific times of day unreasonably loud noise, or noise disturbance, is detrimental to health, safety and welfare of the citizenry and the individual's right to peaceful and quite enjoyment. It is the policy of the City to prohibit noise disturbances or unreasonably loud noise from all sources, subject to its police power, in order to secure and promote the public health, comfort, convenience, safety, welfare, and prosperity of the citizens of Greensboro. Nothing in this Article is intended to deter individuals from lawfully exercising the individual right of freedom of speech or any other freedom guaranteed under the Constitutions of the United States of America or of the State of North Carolina.

Sec. 18-54. Enforcement responsibility for control of excessive noise.

- (a) Primary enforcement responsibility. The Chief of Police of the City, or his Departmental designee, shall have primary enforcement responsibility for noise and sound control pursuant to this Code.
- (b) Powers of arrest or citation. Any police officer shall issue a citation for any violation under this article, except they may arrest for instances when:
- (1) The alleged violator refuses to provide the officer with such person's, or owner's, name and address and any proof thereof as may be reasonably available to the alleged violator; or
- (2) The alleged violator refuses to cease such illegal activity after being issued a citation; or
- (3) Any person interfering with the enforcement activities of the Officer.

Sec. 18-55. Noise Enforcement Officer.

Sec. 18-57. Penalties

(a) Penalty. A violation of this Article by any person subjects the offender to a fine of up to two hundred dollars (\$200.00) and any other punishment authorized by law for a Class 3 Misdemeanor. A second violation by the same person within one (1) year shall subject such person to a fine of up to four hundred dollars (\$400.00) and any other punishment authorized by law for a Class 3 Misdemeanor. All subsequent violations by the same person within one (1) year shall subject such person to a fine of up to five hundred dollars (\$500.00) and any other punishment authorized by law for a Class 3 Misdemeanor.
